

Frequently Asked Compliance Questions (Compliance FAQ)

? Toxic Substance Control Act (TSCA) PBT Substances Compliance

- ✓ To the best of our knowledge, Glenair UK Ltd is fully compliant with Environmental Protection Agency TSCA (Toxic Substances Control Act) Section 6(h) and related controlled substances.

? Do you provide Full Material Disclosure (FMD)

- ✓ We do not provide FMDs as these may contain proprietary information.

? Does Glenair UK Ltd comply to California OEHHA Proposition 65

- ✓ Because Glenair UK Ltd does not deal with consumers (as our customers are industrial) as contemplated by Prop 65, Glenair is not obligated to label our packaging or products. Similarly, Glenair UK Ltd does not respond to part specific requests (as the same are receiving the non-labelled packaging). Further, the substances are only a concern in their uncured form, which is why Prop 65 deals with occupational hazard, or, in other words, with the Glenair UK Ltd employees that have to work with these uncured substances (or the buildings in which people may be exposed to these substances – and Glenair UK Ltd complies with this requirement). The shipped products are in cured form and do not pose a hazard of significant exposure (if used as it was intended) to the receiving end; hence, we are not obligated through Prop 65 to report part specific substances.

? Per-and Polyfluorinated Substances (PFAS) questionnaire

- ✓ Glenair UK Ltd is well aware of PFAS industry concerns and monitoring closely 1) potential government regulation and 2) source of supply. At this time Glenair UK Ltd is not able to provide PFAS data at part level. Glenair UK Ltd uses PFAS in a variety of products (in many instances because we are required per the customer/industry specification). PFAS materials Glenair UK Ltd uses include but not limited to ECTFE, ETFE, FEP, PFA, PTFE, PVDF, and THV. Most of the PFAS Glenair incorporates into our products have no known alternative and are required per mil-spec or customer spec.
- ✓ *Regarding packaging materials only: All packaging products used by Glenair UK Ltd are free from Transmissible Spongiform Encephalopathy (TSE) and Bovine Spongiform Encephalopathy (BSE). Our products are also free from Bisphenol-A (BPA) and Per-and Polyfluoroalkyl substances (PFAS).*
