COMPANY STRUCTURE



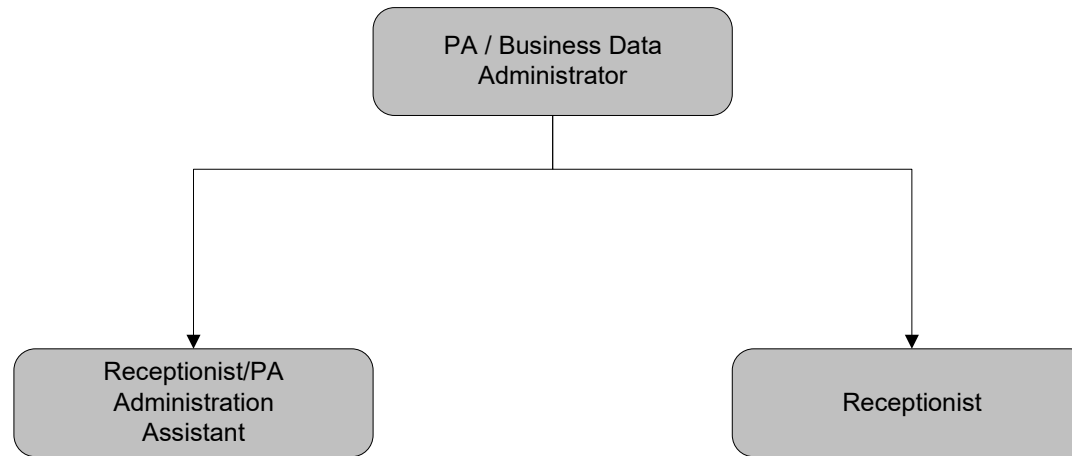

QUALITY ASSURANCE DEPARTMENT STRUCTURE



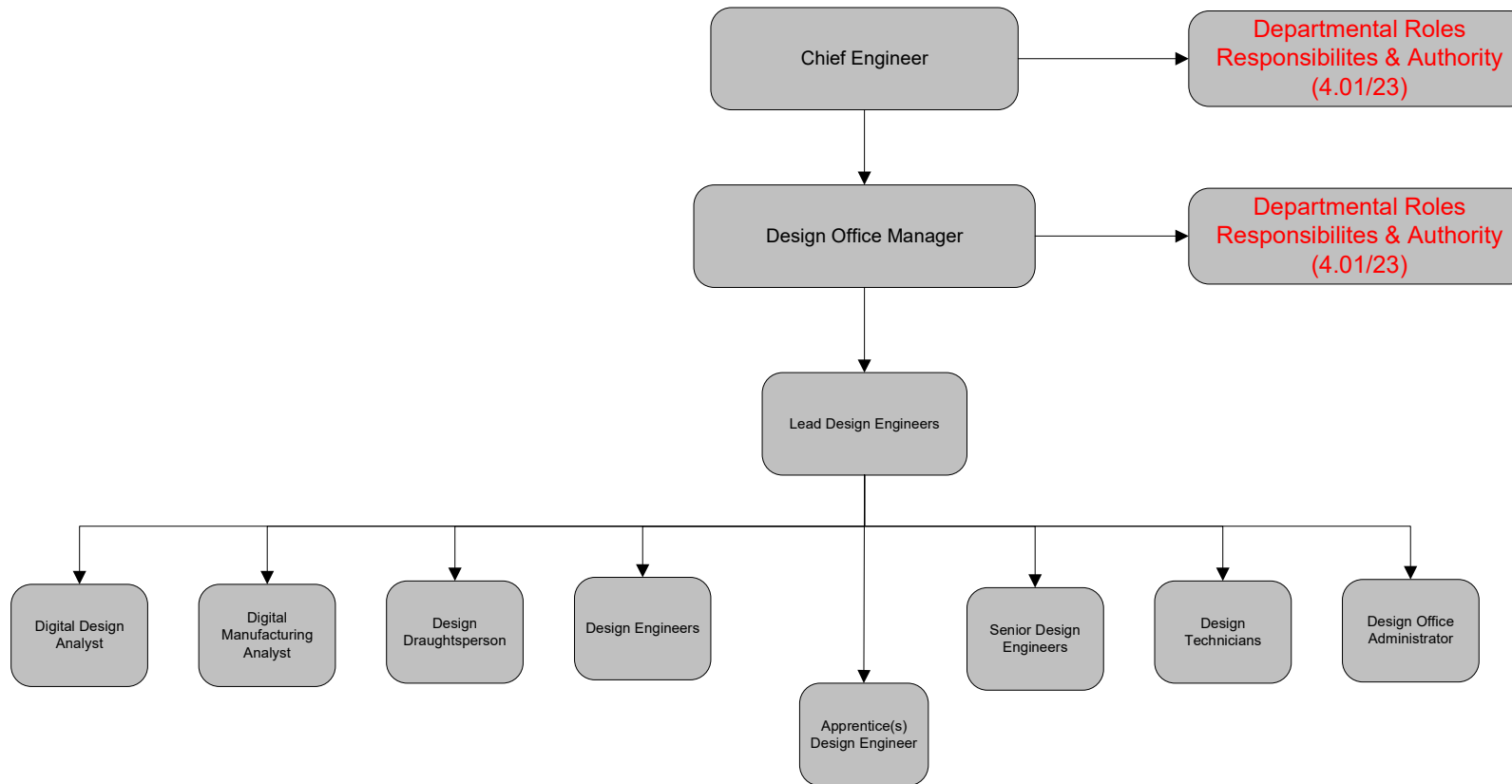

DIRECTOR PA / RECEPTION DEPARTMENT STRUCTURE



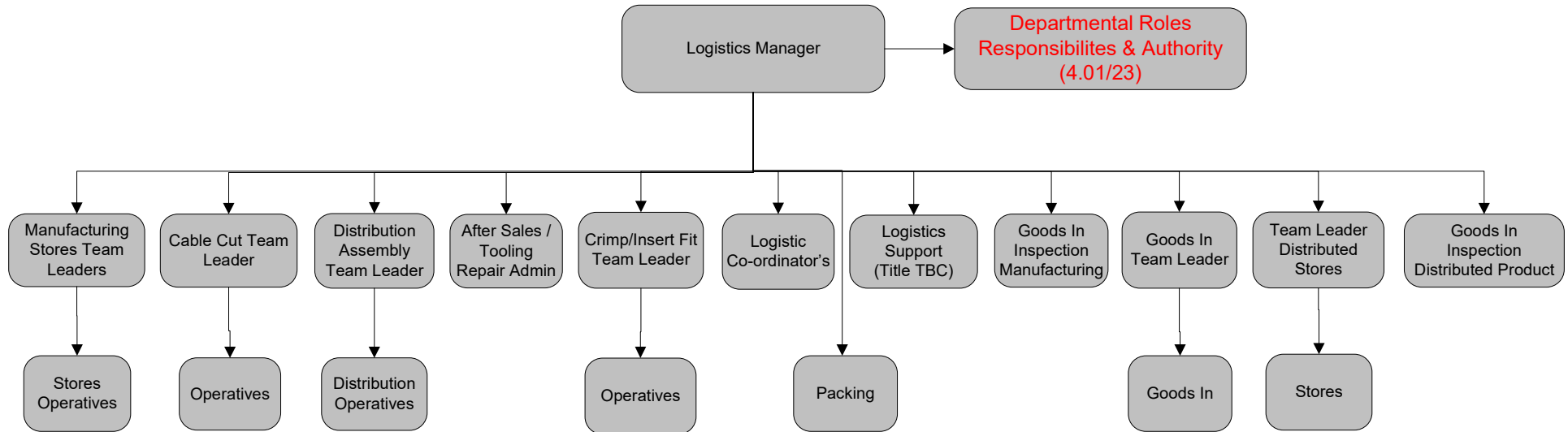

DESIGN ENGINEERING DEPARTMENT STRUCTURE



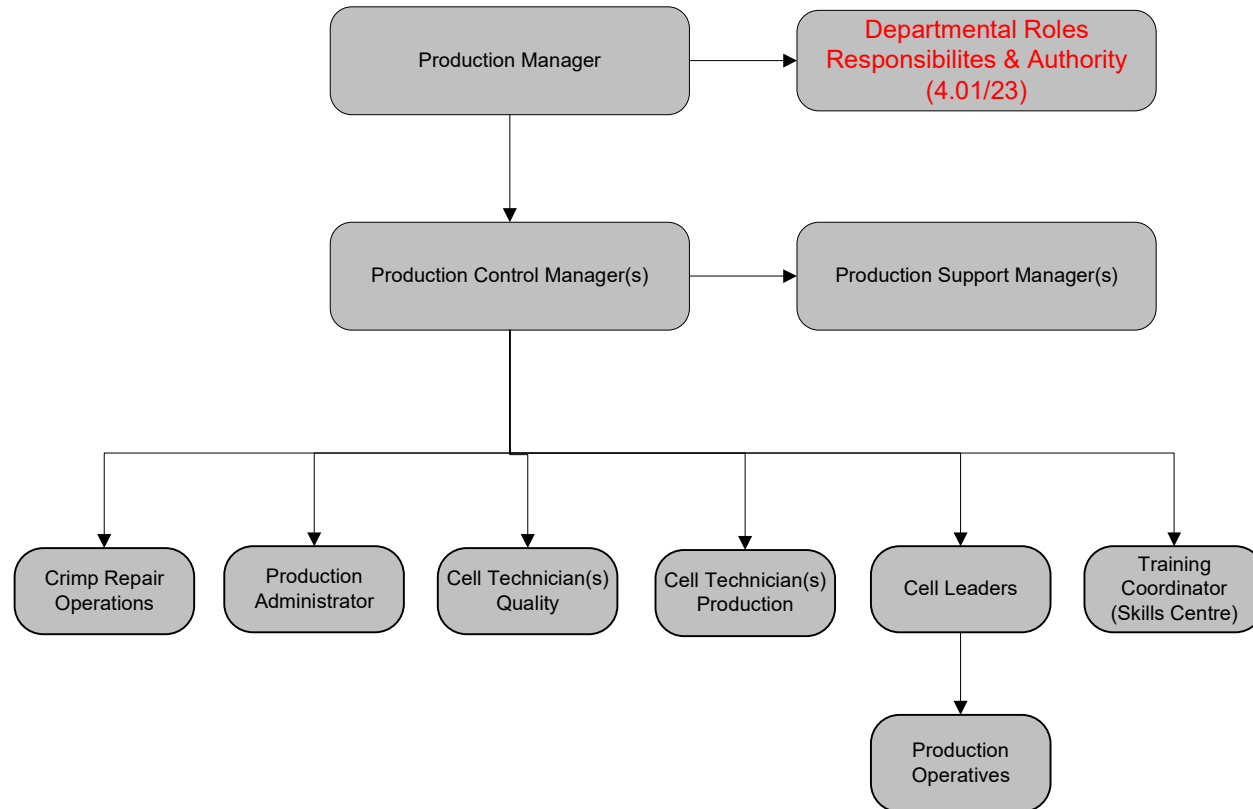

LOGISTICS DEPARTMENT STRUCTURE



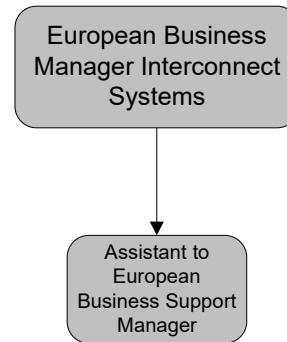

MICRO PRODUCTION CONTROL STRUCTURE



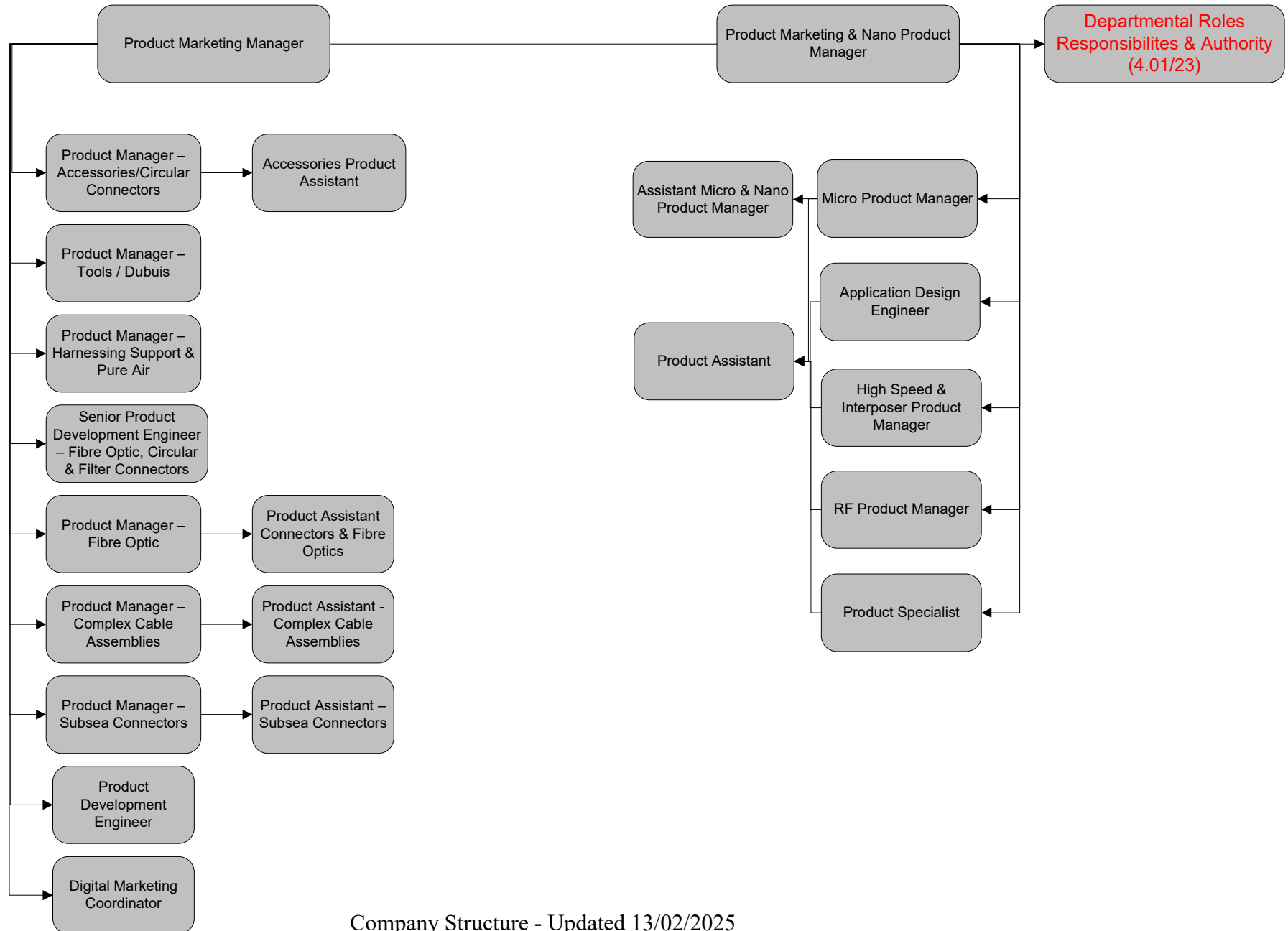

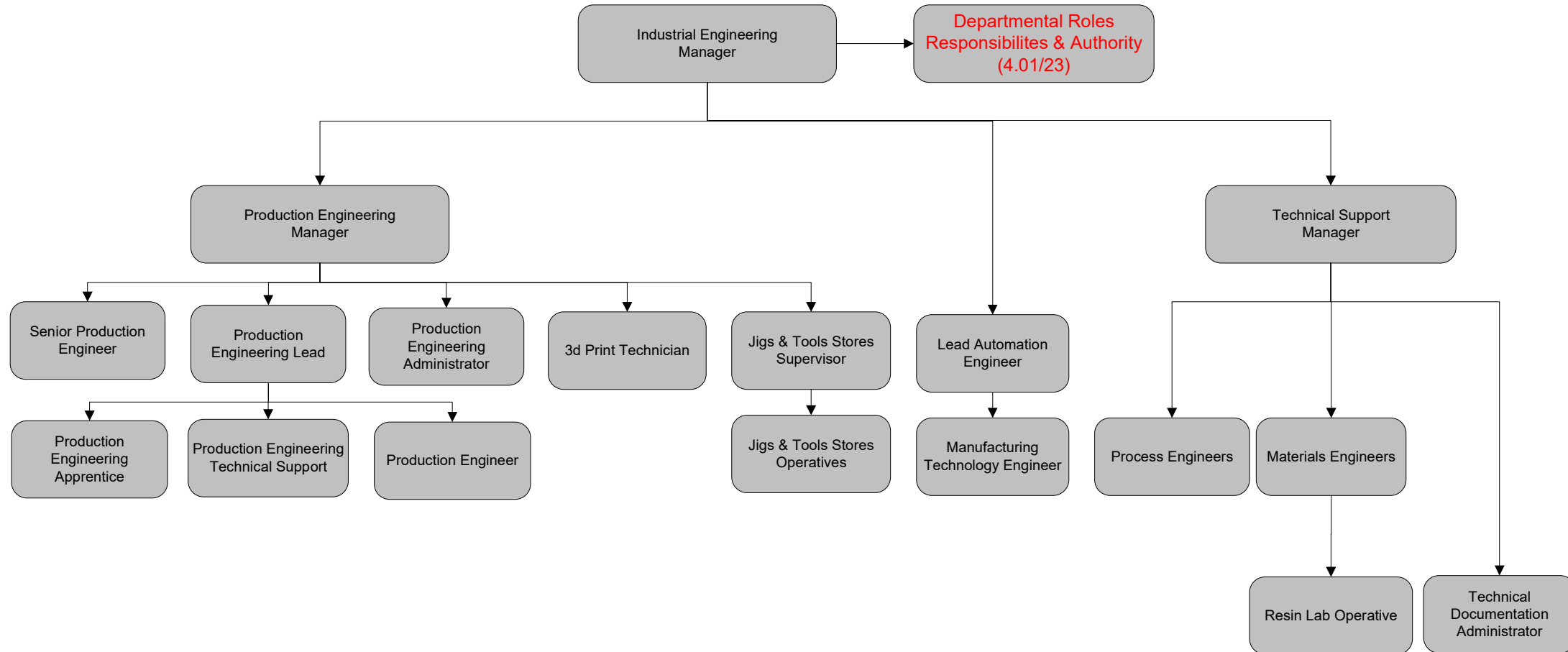

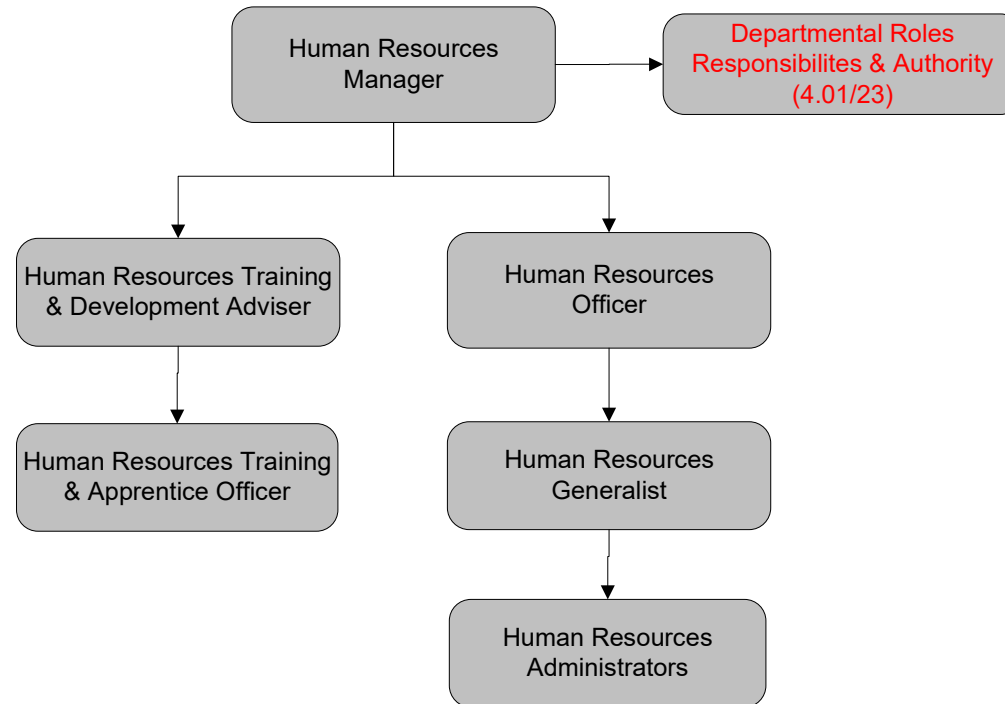

INDUSTRIAL ENGINEERING DEPARTMENT STRUCTURE



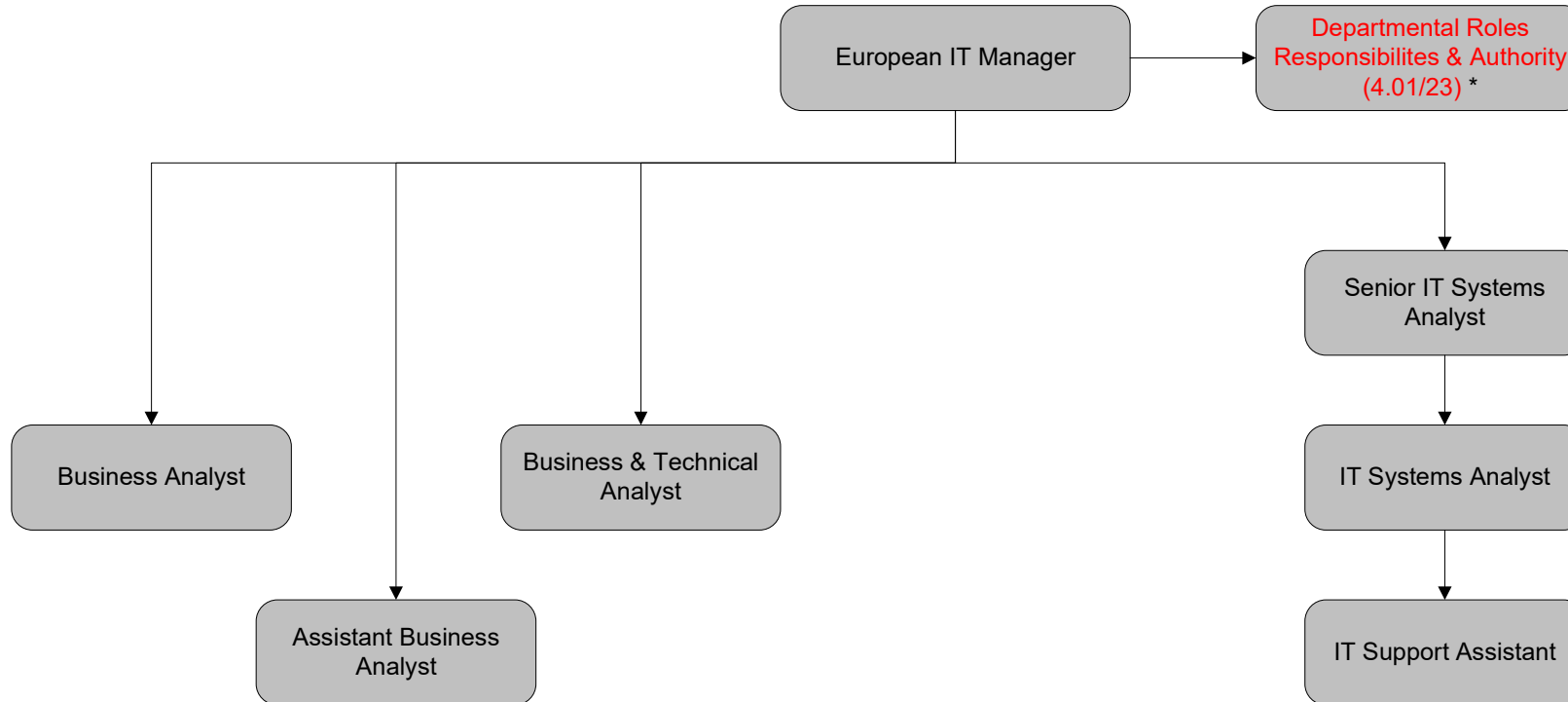

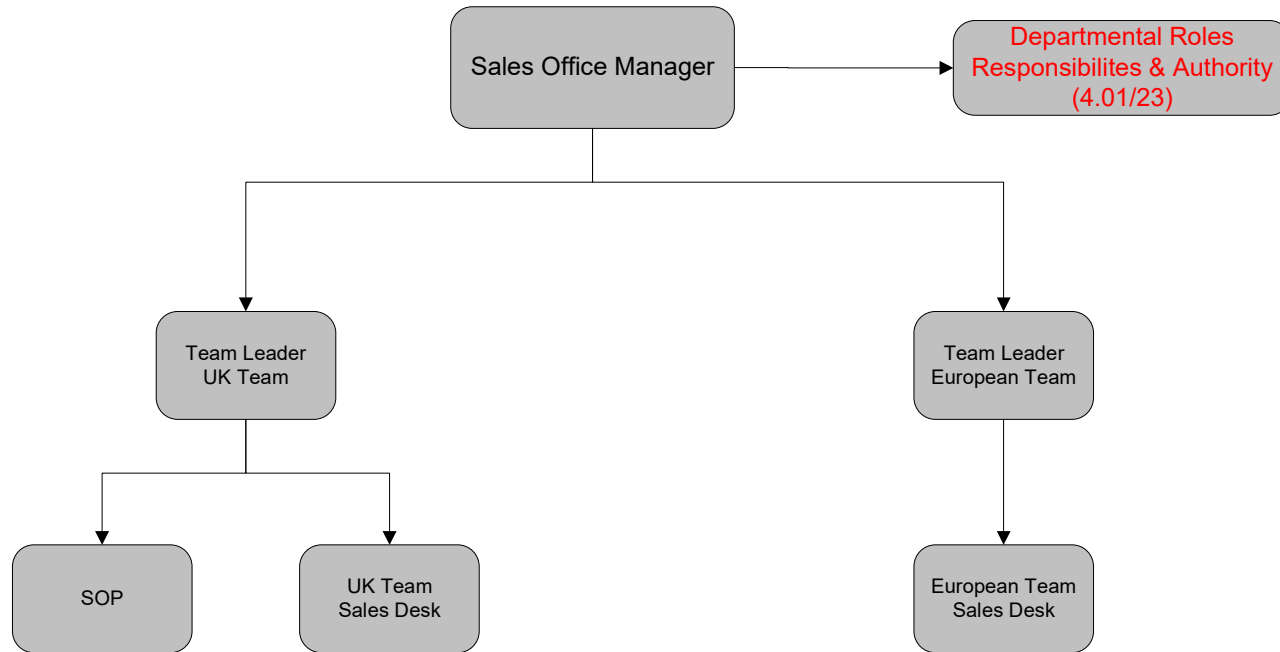
BUSINESS INFORMATION SYSTEMS (BIS) DEPARTMENT STRUCTURE



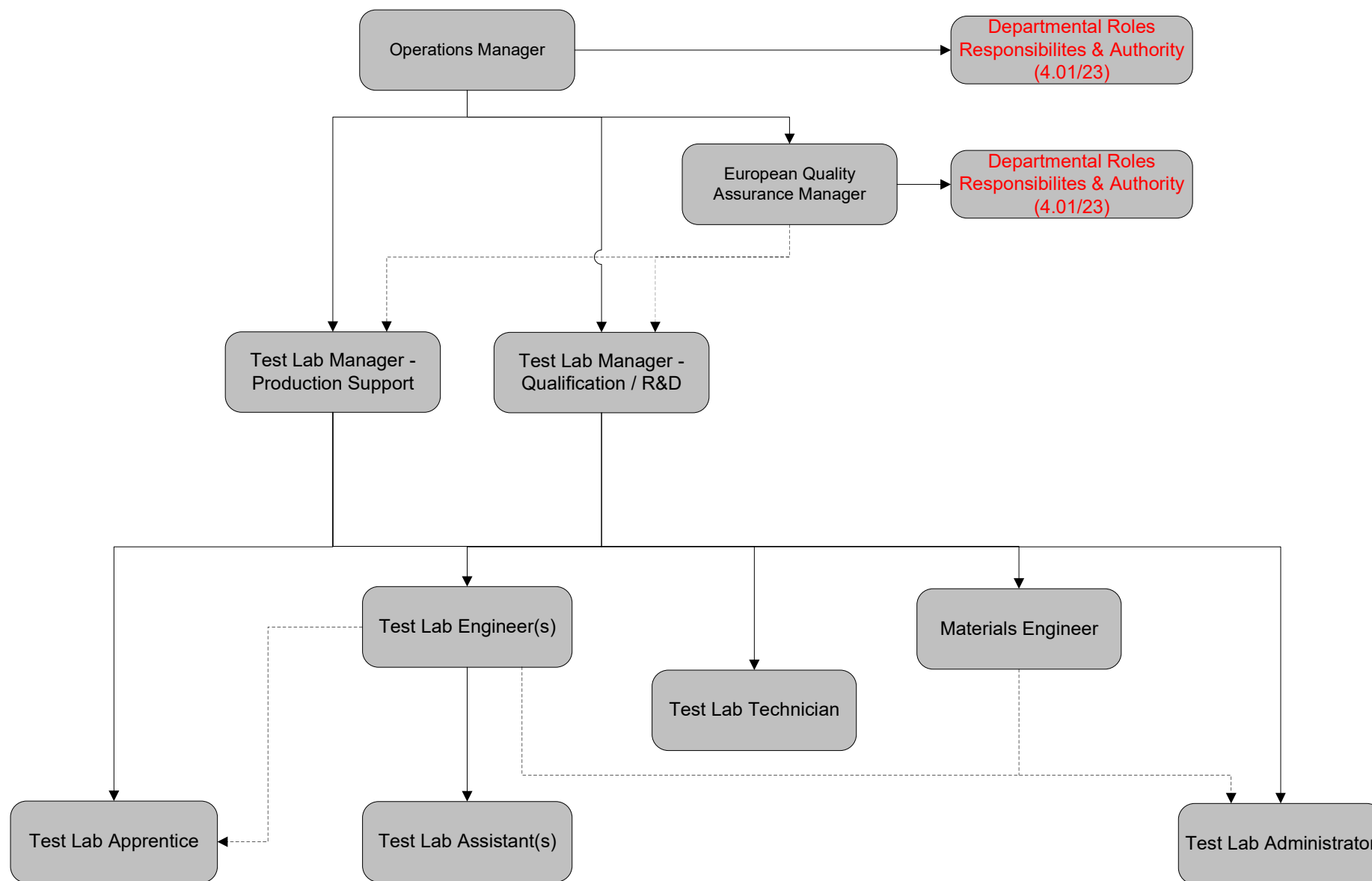

INTERNAL SALES DEPARTMENT STRUCTURE

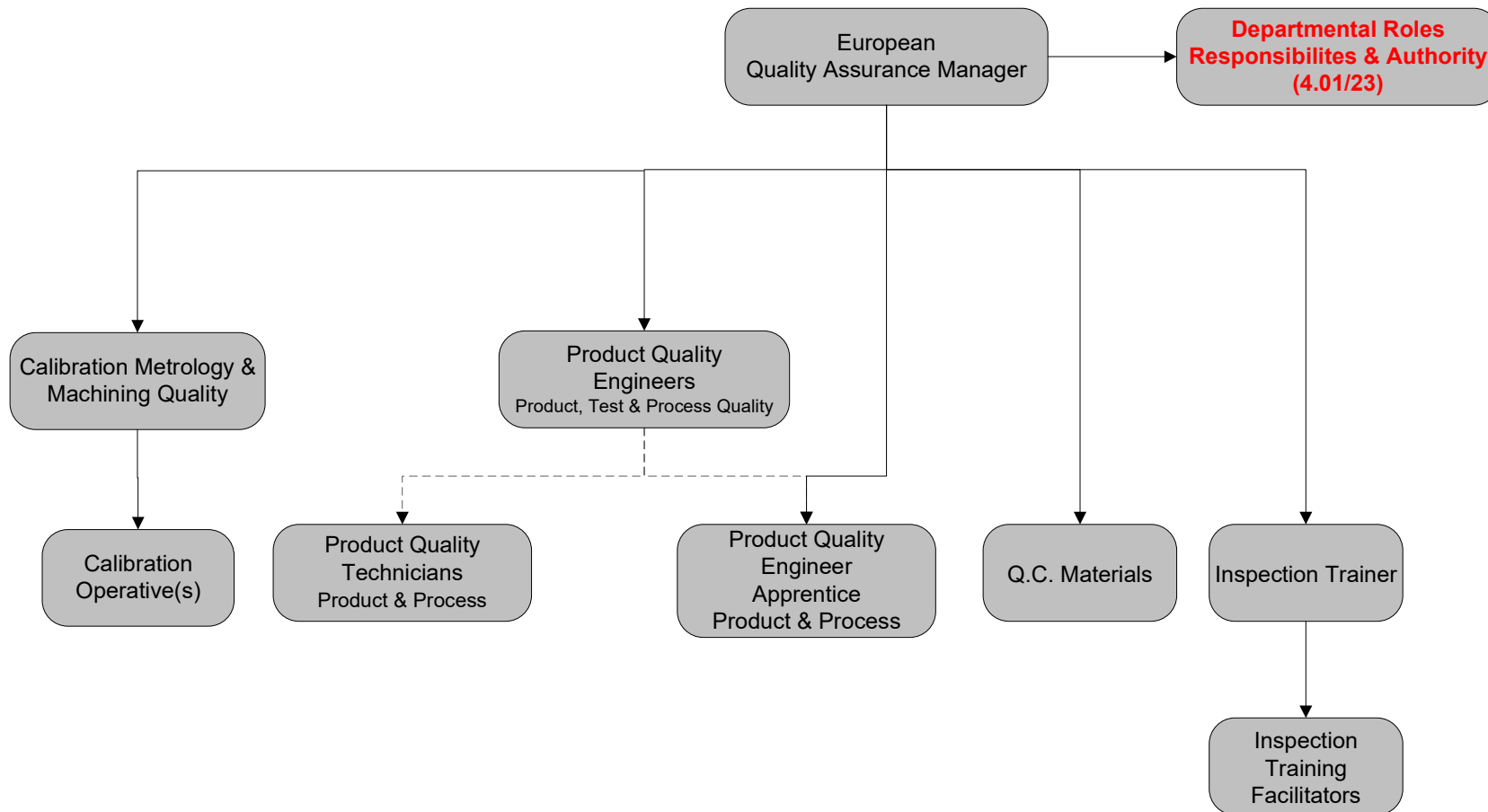

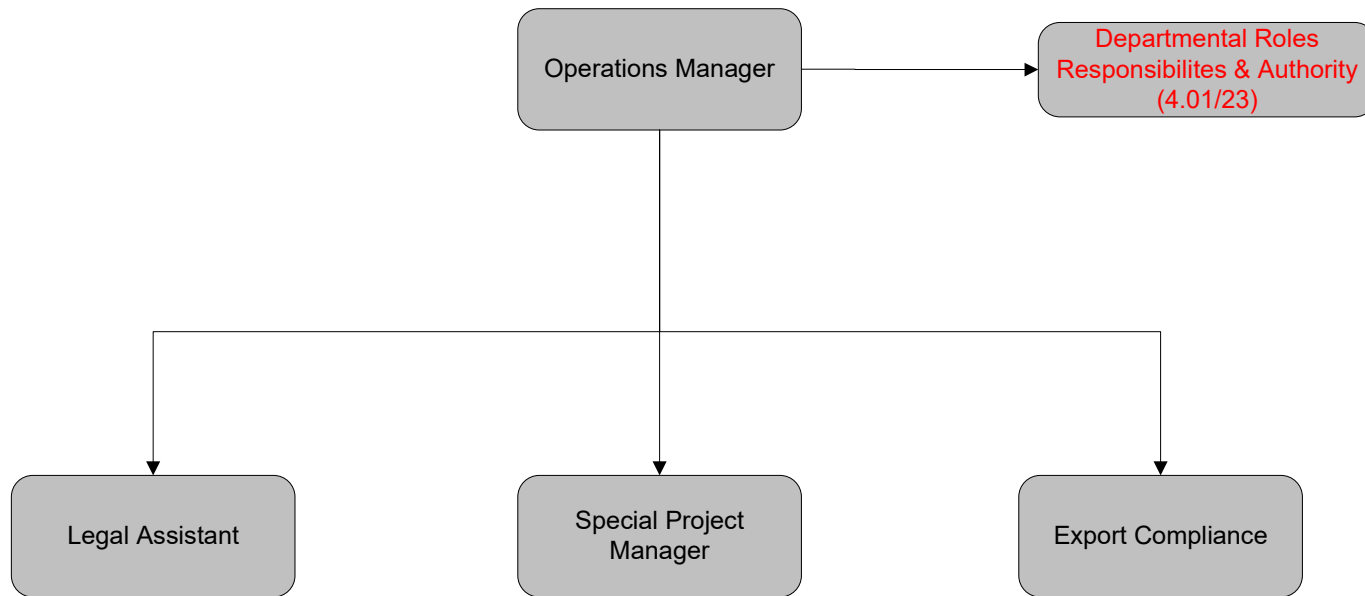

PRODUCT QUALITY DEPARTMENT STRUCTURE



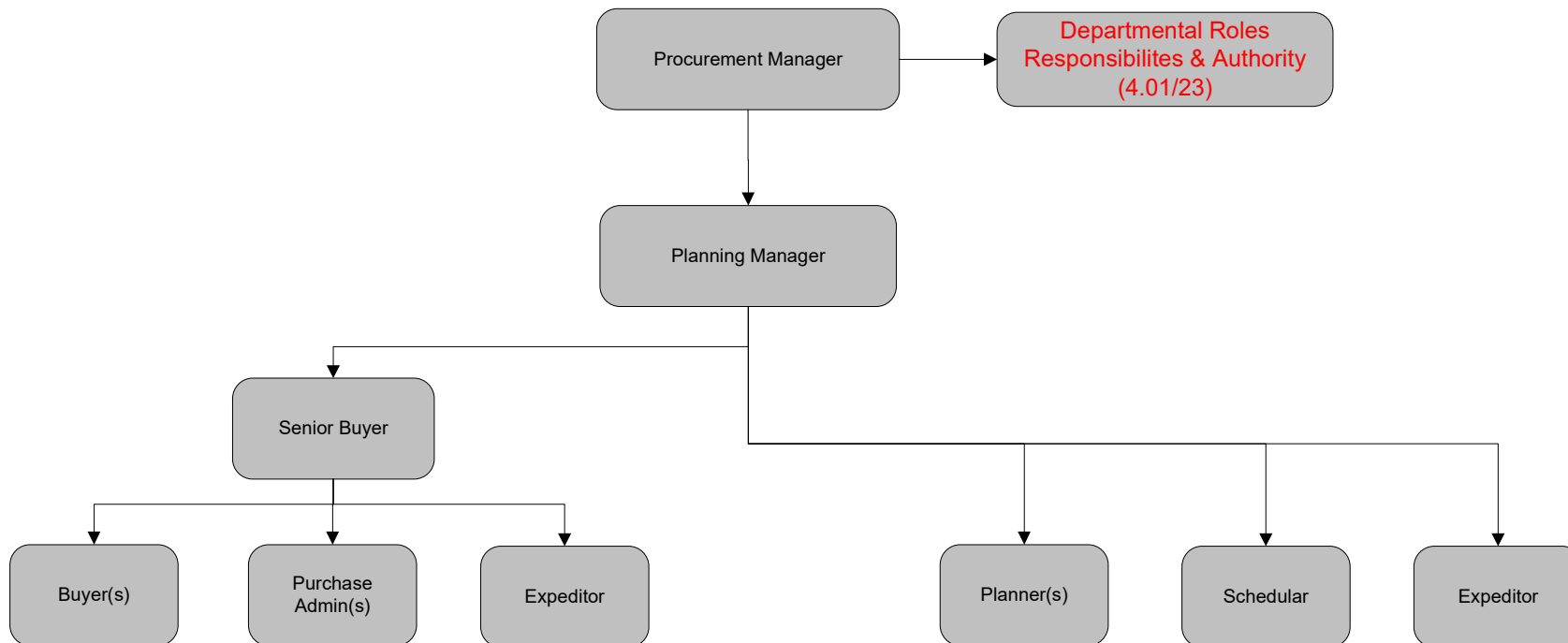

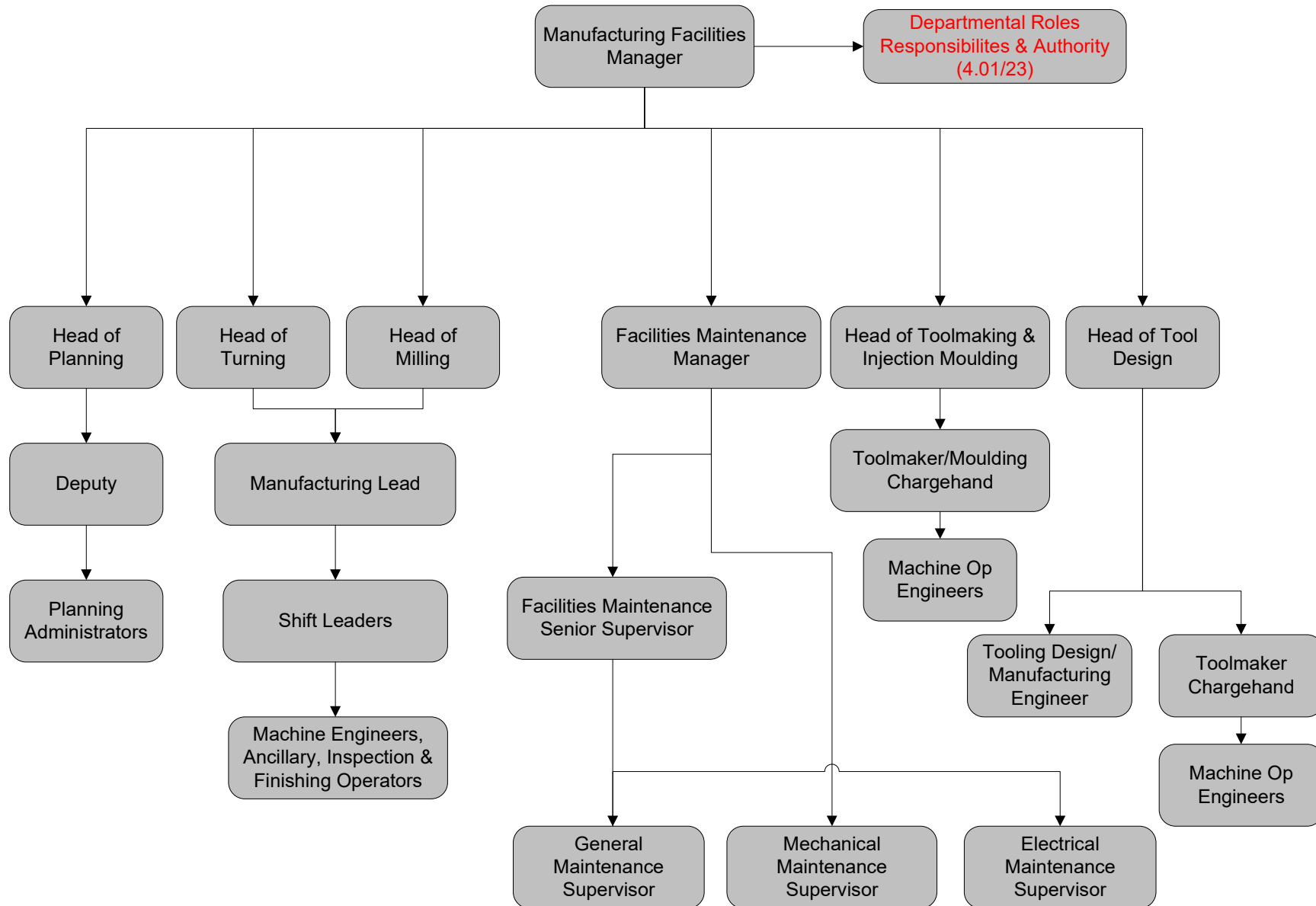

PROCUREMENT AND PLANNING DEPARTMENT STRUCTURE



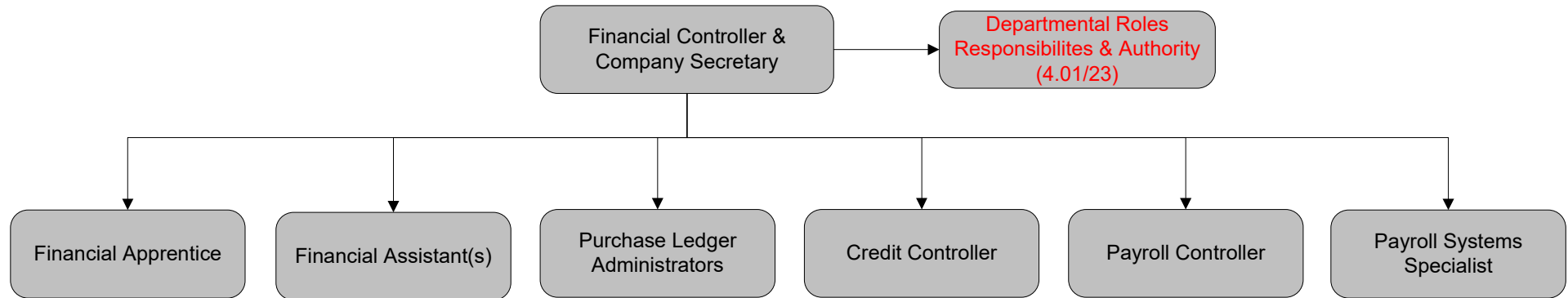

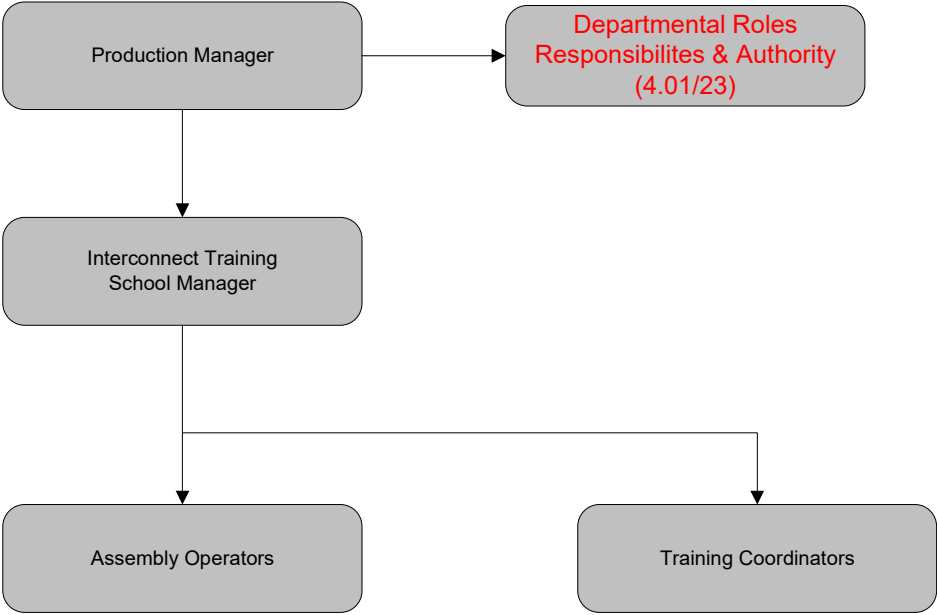

TRAINING SCHOOL STRUCTURE



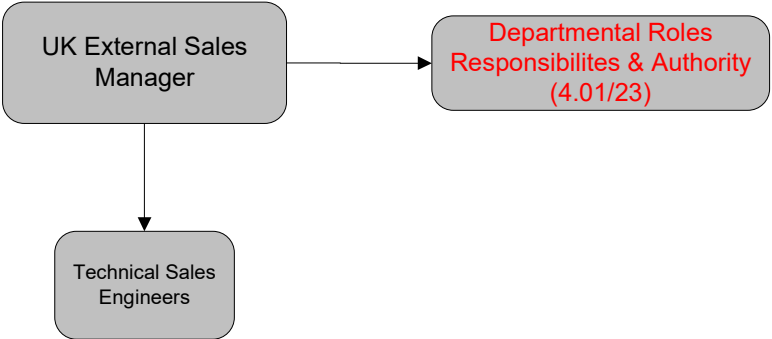

DESIGN ACTIVITY STRUCTURE

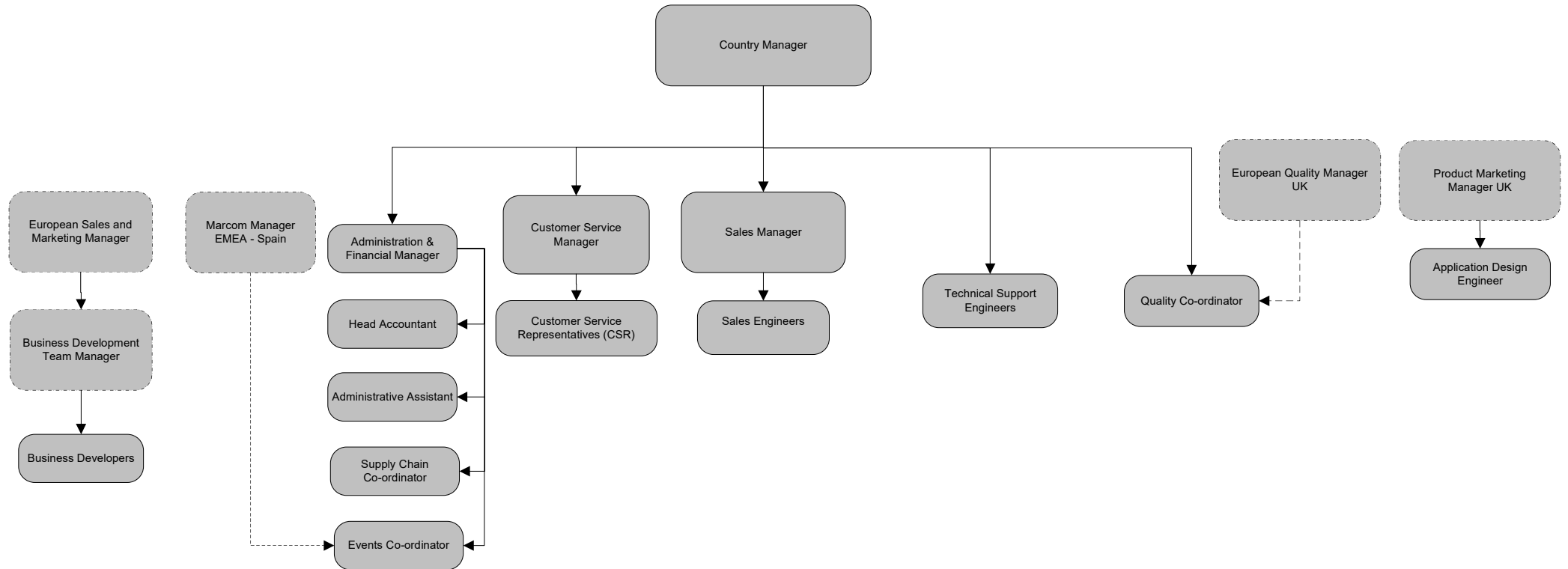
